We refer to your announcement in a recent newsletter to the Fellowship of A.A. Australia:

Message from Your Office and the General Secretary of AA Victoria

Central Service Office have just taken delivery of a large consignment of "Conference" books and pamphlets.

We shall be contacting groups with back-orders prior to packing and sending. If your group has books on back-order and you don't hear from us in the next couple of weeks please contact the office. The books and pamphlets have been imported from the USA and are printed under license from AA World Services.

This letter is intended to confirm that Alcoholics Anonymous World Services, Inc. (A.A.W.S.) owns the copyright to the book *Alcoholics Anonymous* (Fourth Edition) in the United States. And all A.A.W.S., Inc-copyrighted General Service Conference-approved literature. We hold these copyrights in trust for the worldwide Fellowship as mandated in the charter of A.A.W.S.

We've attached a copy of the Copyright Registration (Exhibit A) for *Alcoholics Anonymous*, Fourth Edition.

Moreover, G.S.O Australia is the sole and official licensee of A.A.W.S. and the only entity currently authorized by A.A.W.S. to publish and distribute A.A. literature in Australia. As proof, we have also attached a copy of our license with A.A.W.S. in Australia (Exhibit B) as an example of our currently active licenses in place with the General Service Office of A.A. Australia.

It is our shared obligation to stop parallel importing of Alcoholics Anonymous items of literature to Australia.

The intention is not to prevent alcoholics from accessing A.A. literature. *In fact, it is quite the opposite.* The purpose is to ensure the proper reproduction (printing) and distribution of A.A.W.S., Inc.-copyrighted literature in order to preserve the A.A. structure and uphold the A.A. traditions and principles, so that the General Service Office in each country can effectively distribute A.A. literature to the still-suffering alcoholic.

While we understand and support the important goal of getting literature to the still-suffering alcoholic, we are obligated to do so in a manner that respects the structure of the international A.A. Fellowship.

These practices emerge from decades of experience adhering to A.A. traditions and concepts, to Unity, and to fulfill our primary purpose. They are both a contractual responsibility and a spiritual responsibility and these practices are followed by each G.S.O. worldwide.

The Alcoholics Anonymous books you are importing are available from G.S.O. Australia, and your method of supplying them in Australia is contrary to practices that are integral to supporting the international A.A. Fellowship.

If there are certain items that you wish to distribute in Australia that are not available from G.S.O. Australia, please advise and G.S.O. is obligated to acquire them for distribution in Australia.

By circumventing G.S.O. Australia, your office is actively hurting the international A.A. Fellowship, a society that is dedicated to helping the still-suffering alcoholic, which is our common goal. Therefore, we are not only asking you from a legal perspective, but also from an A.A. traditions and principles point of view, to cease your harmful activities. Please work with us to provide the A.A. literature in Australia through the proper A.A. structure so that together we may help the still-suffering alcoholic.

We look forward to receiving your written confirmation that you agree to work with us and will cease all unauthorized importation of A.A.W.S., Inc-copyrighted literature within ten (1 0) days of the date of this letter.



This application must be executed in duplicate and returned either via fax to: (212) 870-3137 or by regular mail to: David Rosen, Alcoholics Anonymous World Services, Inc. (A.A.W.S.) 475 Riverside Drive, New York, NY 10115. One signed copy will be returned to Applicant.

- 1. Applicant acknowledges and agrees that A.A.W.S. is the sole owner of all U.S. and foreign copyrights in the Licensed Work and that such copyrights are valid and in force.
- 2. A.A.W.S. grants Applicant a non-exclusive license to:
 - a) Reproduce the Licensed Work in the exact form in which it was received by Applicant from A.A.W.S. ONLY, in the country identified above ONLY.
